ANNUAL REGISTRATION/RENEWAL OF REGISTRATION OF EXPORTERS OF TEA 2024

In terms of the Sri Lanka Tea Board Law No. 14 of 1975 and the Tea (Tax and Control of Exports) Act. No. 16 of 1959, all individuals and organizations engaged in the business of export of tea products should register themselves with the Sri Lanka Tea Board.

Applications are now being called by the Sri Lanka Tea Board for registration of new applicants and renewal of registration of the following categories of individuals and organizations engaged in the export of tea products for the year 2024.

Duly completed applications for the below categories should be forwarded with the renewal fees to the Deputy Tea Commissioner, Tea Exports Section, Sri Lanka Tea Board, No. 574, Galle Road, Colombo 3, on or before 30th November, 2023. All cheques for the amount applicable should be drawn in favour of the "Sri Lanka Tea Board".

- * Exporters of tea whose annual volume of tea exported is 1 Million Kgs or above
- Large category
- * Exporters of tea whose annual volume of tea exported is below 1 Million Kgs.

Small category

New/renewal application forms could be downloaded from the Srilanka Tea Board official web site (www.srilankateaboard.lk).

Registration fee for new applicants and renewal fee for registered exporters of tea are appended below:

- * New Applicant (For Exporter and Packer registrations)...... Rs.50,000/- + 15% VAT
- * Renewal of Small Category...... Rs.50,000/- + 15% VAT

All registered exporters of tea shall renew their registration for the year 2024 on or before 31st December, 2023.

In addition those who are engaging in tea exports activities through online are also required to register according to the above procedure.

Kindly note that your application should be forwarded on or before 30th November, 2023

- a) Certified copy of Business Registration
- b) Certified copy of form 20 and Form 1 (Only for Limited Companies and Public Limited Companies).
- c) Original letter of consents from the warehouse owners and the applicant's requests to use the same warehouse for the year 2024. (If warehouse facilities are not owned by the applicant)
- d) Copies of warehouse registration certificates for the year 2024. (For warehouse owners)
- e) Copy of the payment of renewal fee (payment to be made to the Finance Division of the Sri Lanka Tea Board) and please make sure your export category would be decided based on the export statistics from 1st October 2022 to 30th September 2023.

Please make sure to comply with following conditions prior to submit your Exporter & Packer applications.

- (1) If warehouses of other companies are used, please make sure that renewal application of such warehouses are already submitted to Sri Lanka Tea Board and name of your company is already included in their warehouse renewal application as "other users".
- (2) If you are a holding company with several subsidiaries which are registered with Sri Lanka Tea Board please include their names into relevant warehouse renewal applications as other users.
- (3) Those who are having provisional/Temporary registration certificates should submit a request letter for extension of their exporter and packer registration along with the renewal application form with all past export statistics/export performance.

Please note that your exporter registration should be renewed on or before 31.12.2023

SRI LANKA TEA BOARD (REGISTRATION OF TEA PACKERS)
REGULATION - 1986

REGISTRATION / RENEWAL OF REGISTRATION OF TEA PACKERS FOR EXPORTS OF TEA FOR THE YEAR 2024

In terms of the above regulation published in the Gazette Extraordinary No. 386/13 of 28th January, 1986 and Gazette Extraordinary No. 2248/36 of **6th October 2021**, no person or body of persons shall engage in the business of packing tea, unless such person or body of persons is registered with the Sri Lanka Tea Board.

- Accordingly, all the registered tea exporters in the Sri Lanka Tea Board engaging in the business of packing tea in all forms of packaging for export market, are hereby advised to apply for registration or renewal of the registration for the year 2024 to the Deputy Tea Commissioner (Tel: 0112504090), Sri Lanka Tea Board, Tea Export Branch, No. 574, Galle Road, Colombo 3 on or before 30th November, 2023 in the prescribed form obtainable from our official web site (www.srilankateaboard.lk).
- The applicable fee for a new registration would be Rs. 25,000/- + 15% VAT. (Payable Fee would be Rs. 28,750/-).
 Every registration shall be renewed annually on or before 31st December of the current year. The renewal fee would be Rs. 10,000/- + 15% VAT (Payable Fee would be Rs. 11,500/-).
- 3. In the aforesaid regulation, unless the context otherwise requires "Export tea Packer" means a person or body of persons who packs tea in consumer or catering packs not exceeding five kilograms (5kg) in such containers as cartons, canisters packets, wooden boxes, cans, porcelain jars, reed packs or any other form of retail packing for export.
- 4. Every person who contravenes or fails to comply with any provision of these regulations or furnishes false information or returns to the Sri Lanka Tea Board shall be guilty of an offence, punishable in terms of these regulations.
- 5. Payment of registration fee or renewal fee could be made either in cash or cheque. All cheques should be drawn in favour of the "Sri Lanka Tea Board".
