#### REGISTRATION OF LOCAL TEA PACKERS FOR THE YEAR 2024

In order to safeguard the quality of the tea presented to the domestic consumption. All the persons or bodies engaging in the local business of tea are required to register or renew their registration of local tea packer for the year 2024. In terms of this regulations published in the Gazette Extraordinary No. 386/13 of 28th January 1986, & Gazette Extraordinary No. 2248/36 of 06th October, 2021 all the local tea packers should be registered & renewal with the Sri Lanka Tea board.

The Tea Packers will be registered & renewed under 3 categories, on the basis of the expected monthly sales volume. The registration fee & renewal fee for each category is appended below.

Between 2501 to 5000 Kg	Rs 10,000.00	Rs 5,000.00

Local tea supplier registration will be carry out under 3 main categories on the basis of monthly sales volume

Medium	2501 KG to 5000 KG	Rs 10,000.00	Rs 11,500.00

#### Basic Requirements for the registration

- Applicants should have a valid business registration to engage with Local tea business.
- All the suppliers should needs to furnish the sample of the retail container together with a representative sample of the tea content. Sample should comply with the ISO 3720 quality standard.
- Hygienic and other requirements of the premises in which the packaging operations are carried out.
- In the terms of the Sri Lanka Tea Board (Warehousing of Tea) regulation 1984 published in Government Gazette Extraordinary No 326/17of December 5th 1984 , storage of any quantities of tea in excess of 1000 kgs at any one time and which Sri Lanka Tea Board considers satisfactorily for the purpose of storing of tea has to be registered with the Sri Lanka Tea board.
